**The Arizona Working Poor Charitable Tax Credit
helps developmentally disabled low-income
children and adults.**

One way to make a difference in the lives of developmentally disabled children, adults, and their families is through the Arizona Charitable Tax Credit. A donation of any amount, up to \$200 per individual or \$400 per couple, will qualify you for a State income tax credit. This is not a deduction but rather a tax credit against taxes you may have already paid.

- The tax credit is open to anyone who files itemized Arizona taxes.
- There is no longer a baseline year requirement.
- Arizona allows its taxpayers to designate how their tax dollars are spent. There are three tax credits and taxpayers may utilize all of them in the same year— Working Poor, Public School, and Private School Tuition tax credit.
